

Lumix S Series Camera Trade-In Promotion

DEFINITIONS

This must be purchased new and not second hand from a participating retailer in the UK, Republic of Ireland, Channel Islands or Isle of Man during the Promotion Period.
Qualifying product for trade in	Means any working DSLR or mirrorless camera.
Promotion Period	Period between 23:59 on 30 th March 2021 to 00:01 on 2 nd August 2021.

PROMOTION TERMS AND CONDITIONS FOR END CUSTOMERS

1. The **S Series trade-in Promotion** (hereafter referred to as the “Promotion”) is promoted by Panasonic UK, a branch of Panasonic Marketing Europe GmbH, whose registered address is Panasonic, Maxis 2, Western Road, Bracknell, Berkshire RG12 1RT, UK (the “Promoter”).
2. The S Series trade-in is a Promotion which allows participants to trade in their old DSLR, DSLM or mirrorless digital camera and receive a rebate for a new Lumix S Series Camera provided it is a Qualifying Product as specified in the table in Clause 6.

ELIGIBILITY

3. The Promotion is applicable to residents of the UK, EEA, EU, Switzerland, Channel Islands and Isle of Man who are aged 18 years or over.

10. To make the claim, the participant must purchase a qualifying camera during the Promotion Period and trade in a DSLR/DSLM/Mirrorless camera.
11. The participant must only trade in one camera for each qualifying purchase they make.
12. A maximum of two Trade in Bonus claims can be made per person.
